

## **Lynn Miles Sunflower Indictment 2015**

Lynn Miles frequently attended the site of last year's March 18 Legislative Yuan occupation to convey his support for the movement's goal of opposing the services trade agreement with China and expressed his support for the non-violent civil disobedience actions of the student protestors.

Lynn also entered the Executive Yuan compound on the evening of March 23, 2014, entered a building in the Executive Yuan complex, and photographed so-called "Executive Yuan documents" which showed how civil employees were assigned the duty of boosting the number of hits on the government website. In a blog later quoted by the Liberty Times, he used the colorful term "masturbation" to describe this.

在去年三一八反服貿站領立法院運動時間,梅心怡常常出現在活動現場及公開表達聲援學生的公民不服從的行動.去年三月23日晚上,梅心怡跟著幾千台灣公民與學生進入行政院,並在2樓以手機翻拍揭露上班衝網頁點擊率的"行政院公文".

The official indictment received by Lynn Miles from the Taipei District Prosecutors Office issued 25 February 2015 charged him with "trespassing" or "entering the dwelling or structure of another person without reason" under Article 306-1 of the Criminal Code. The indictment also identified Lynn as female.

2015年2月25日台北地檢所送來的公文表明以刑法306條"侵入住居罪"(無故侵入他人住宅、建築物或附連圍繞之土地或船艦者,處一年以下有期徒刑拘役或三百元以下罰金)的罪名起訴梅心怡,起訴書公文也指定梅氏爲女性.


Lynn told officers of the Bureau of Criminal Police last May that he had followed other people into the Executive Yuan complex and that no police officers blocked his entry and therefore he did not know that such an entry was "illegal."

去年五月在律士陪同下,梅氏向台北市刑大說明他是跟隨人群進入行政院,而且當時警方沒人阻擋 他,所以,他不知道這樣的行爲是違法的.

Recently, Lynn told friends that he planned to question in court how the Executive Yuan could be legally considered "the dwelling of another" since it is owned collectively by all Taiwan taxpayers, including Lynn Miles himself.
